Kid's Que Rules & Regulations

1. Each participating team will receive one numbered Styrofoam judging container.
2. Team participants must be between the ages of 7–12 years old.
3. A parent or guardian must be present on site at all times, from set-up to tear down, for each participating team). Any team not under adult supervision will be disqualified.
4. Each team will be provided with a small tabletop charcoal grill.
5. Each team will be cooking pork burgers only.
6. Each team will be assigned a cooking area with a table and we request that you keep all of your equipment within this area.
7. A mandatory Cook's Meeting will be held at 1:00 p.m. All teams must be present for this meeting.
8. Each team will be provided with 1 lb. ground pork and charcoal.
9. All other seasonings, condiments, garnishes, buns {if you choose to use them}, and cooking utensils must be provided by each team.
10. Team participants must do all preparations, seasoning, and cooking of their entry.
11. Adults may help ONLY with lighting the fire, assistance with hot grills, and using a knife to cut any vegetables. Adult participation outside of these boundaries will cause the team to be disqualified.
12. Teams must hold the entries at a temperature of 140° or higher until turn-in.
13. Official turn-in time will be 2:30 p.m. with a 10-minute window {5 minutes before 2:30 to 5 minutes after 2:30}. **NO LATE ENTRIES WILL BE ACCEPTED.**
14. Each team must turn in no less than TWO 1/4 lb individual pork burgers or FOUR sliders in the numbered container.
15. The judging for this event will be "double blind" to ensure the integrity of the event.
16. Judging will be based on appearance, tenderness/texture, and taste. Certificates will be presented for 2nd through 10th places. Only one Grand Champion will be named and s/he will receive a trophy and prize money.
17. Each team is responsible for the clean-up of their assigned cooking area. Trash and hot ash disposal containers will be placed within the Kids' Que area.
18. Failure to follow any of these rules will be cause for disqualification of the team.

Limited number of spaces available, so mail your application as quickly as possible.

The Barbecue Cook-off Committee reserves the right to reject any application.

I grant permission to use any photos, videotapes, motion pictures or record of this event for any legitimate purpose.

I understand that I am responsible for my team's conduct. We agree to behave in a courteous and professional manner that upholds the spirit of barbecue. I understand that failure to comply with this rule may mean ejection from the contest or disqualification. **I understand that QUIET TIME starts at 12 midnight Friday; I will turn my music DOWN. {Not applicable to Kids' Que contestants.}**

Waiver of Liability: In consideration of accepting this entry, I the undersigned, agree to indemnify and hold harmless the Memphis Barbecue Network, Kansas City Barbecue Society, City of Murphysboro, 17th Street Bar & Grill and its employees, Mike Mills, the Murphysboro Barbecue Cook-off and committee and all sponsors including Budweiser-Venegoni Distributing Co., City of Murphysboro, Republic Services, Murphysboro Businesses, Murphysboro Chamber of Commerce, The Kroger Co., Hensen Sanitation, 17th Street Bar & Grill, Pepsi, Ole Hickory Pits, Silkworm, and Schwebel Printing.
